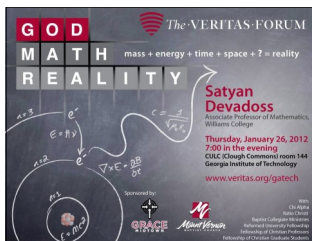
Dear friends and partners,

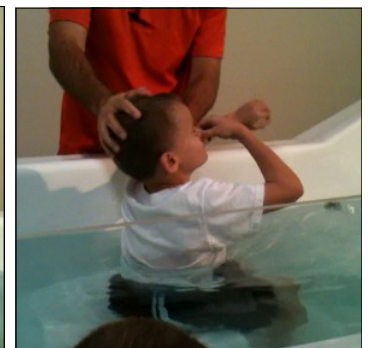
